#### **NEW CLIENTS**

In 2016 we assisted 433 families for the first time. They needed food, clothing, or help with bills.

#### FOOD PANTRY

Our mission is to provide food to families in need. In 2016 we serviced 3,410 families, distributing 239,460 pounds of food and personal hygiene items. This benefited 7,796 individuals which includes 2,422 children. A large percentage of this food came from our community partners as well as Forgotten Harvest, Waterford Panera Bread, Meijer Simply Give, White Lake Community Garden, Waterford Insurance and private gardens.

#### **EASTER MEALS**

We provided 106 families with food for a special Easter dinner including pie! A total of 2,650 pounds of food was distributed to 127 children and 206 adults.

**TOTAL VALUE: \$4,797** 

#### **BACK TO SCHOOL PROGRAM**

New back packs filled with grade appropriate school supplies, a shopping trip to Meijer for new clothing, and a Resale Store gift card were provided to 44 children, grades K-12, from 22 families. Throughout the month of October and September our families used vouchers in the Resale Store to purchase clothing for their children.

**TOTAL VALUE: \$5,270** 

#### **THANKSGIVING MEALS**

We provided turkeys and all the fixings for a complete holiday meal for 120 families. This fed 400 adults and 169 children. Our low income families & elderly appreciate our holiday meals.

**TOTAL VALUE: \$7,800** 

#### CHRISTMAS / HOLIDAY MEALS

We focus on families often overlooked. Seniors, adults living alone, disabled, parents and children from 176 households were given a complete holiday meal with turkey, stuffing, potatoes, gravy, vegetables, rolls, cool whip & pie!

**TOTAL VALUE: \$6,825** 

# ADOPT A FAMILY CHRISTMAS/HOLIDAY PROGRAM

Families and businesses participated in our Adopt A Family Program, providing gifts to 42 of our families with 136 people. Client Services distributed \$3,095 in gift cards to help brighten Christmas/Holiday. In addition, we received a generous \$1,000 grant to give a \$25 gas cards to our clients during the last weeks of December.

**TOTAL VALUE: \$13,600** 

#### 2016 CHILD SUMMER FOOD PROGRAM

We distributed additional food in June –August 2016. Summer is a difficult time for very low income families. Instead of children receiving a free breakfast and lunch at school they are home and hungry. Families do not have additional funds for meals and snacks throughout the day. Client families with children in the household received extra bags filled with child-friendly breakfast and lunch items at each of their monthly pantry visits. This program is supported by donations, churches, scout troop & U.S. Post Office food drive. 143 families with 237 children received 2059 pounds of food or 1,716 meals.

**TOTAL VALUE: \$2,059.20** 

# CLOTHING & HOUSEHOLD VOUCHERS PROGRAM

Our Resale Store, open to the public, is supported by items donated from our generous community. Free clothing and household items were given to 499 households valued at \$28,709. These items help clothe the family and provide household items to restart a home. Client Services distributed to 759 people donated items of socks, pj's, back packs, winter coats, hats etc. valued at \$24,064.

**TOTAL VALUE: \$52,773** 

#### **CRISIS FUNDING**

When funding is available, Open Door provides emergency funds to prevent evictions, utility shutoffs, fuel only gas cards, car repairs, medical needs, etc. 1,258 families were helped with \$11,956 in funds/support. In addition to funds provided directly by Open Door, we collaborate with many other church partners to secure additional funding to prevent crisis.




